This limited warranty does not cover labour or other costs or expenses incidental to the repair and/or replacement of products or parts. This limited warranty is in lieu of all other warranties, express or implied, including those of merchantability or fitness for a particular purpose not expressly set forth herein. SP Cylinders' liability (whether under breach of contract or warranty, negligence, or strict liability) for its products or services shall be limited to repairing or replacing parts found by SP Cylinders to be defective, or at SP Cylinders' option, to refund the purchase price of that product or service. In no event shall SP Cylinders be liable for incidental or consequential damages arising out of or in connection with its products or services. Consequential damages shall include, without limitation, loss of use, income or profit, or losses sustained and the result of injury (including death) to any person, or loss of or damage to property. The parties hereto expressly agree that the purchaser's sole and exclusive remedy against SP Cylinders shall be for the repair or replacement of the defective product as provided in the limited warranty. This exclusive remedy shall not be deemed to have failed of its essential purpose so long as SP Cylinders is willing and able to repair or replace defective goods. SP Cylinders does not offer any design services or recommendations, and therefore offers no warranty relating to modifications requested by a customer other than as described above
